<b>COUNSEL REGISTRATION</b>	Counsel must register with the Clerk's Office in the library on the 2nd Floor between <b>8:30a.m. and 9:30a.m.</b>
<b>REQUIRED RESPONSE</b>	<b>Each arguing attorney must complete and return the Response to Notice of Oral Argument by 01/15/2020.</b> If counsel presenting oral argument has not yet entered an appearance, counsel must file an entry of appearance form concurrently with the Response.
<b>ARGUMENT TIME</b>	<b>Panel Hearings:</b> Each side receives 15 minutes (including rebuttal), unless otherwise directed by the court. <b>En Banc Hearings:</b> Each side receives 30 minutes. <b>Note:</b> In cases where one side has multiple parties represented by different counsel and firms, counsel should confer and agree with each other on the apportionment of time before submitting their responses to the Notice of Oral Argument because the 15 minutes of argument time is shared among those parties. Appellants and Cross-Appellants may divide argument between main argument and rebuttal, Appellees may not. In cases involving both Cross-Appellants and Appellees, those parties must share the 15 minutes of argument time.

### ADDITIONAL INFORMATION

<b>ACCESSIBILITY ACCOMMODATIONS</b>	Requests for any communications-related disability assistance (ASL, CART) must be submitted <b>at least two weeks</b> before the date scheduled for argument. <b>AUDIO FILES ON INTERNET</b>	Oral argument audio files are posted on the court's website, <a href="http://www.cafc.uscourts.gov/oral-argument-recordings">http://www.cafc.uscourts.gov/oral-argument-recordings</a> , by the next business day.
<b>CONFIDENTIAL AND SEALED MATERIAL</b>	Because all arguments are by default open to the public and recorded for posting on the court's website, counsel should be careful not to discuss any sensitive, confidential, or sealed information during argument. <b>Any motion to seal the courtroom for oral argument must be filed at least one week before argument.</b>
<b>COURT SECURITY</b>	Please plan to allow additional time for security screening. Counsel and staff must show photo identification and pass through security screening upon entering the courthouse. Weapons, food, and beverages are prohibited.
<b>COURTROOM SEATING</b>	Only Federal Circuit bar members may sit at counsel tables and address the panel in the courtroom. Parties to the case must sit in the public gallery, unless they are also members of the bar. The courtroom opens one hour before the argument begins; general seating is available on a first-come, first-served basis.
<b>DIGITAL CLOCK</b>	The digital clock on the podium provides a countdown of the time remaining of your argument, along with color-coded light cues: <ul style="list-style-type: none"> <li>• <span style="background-color: green; color: black;">Green</span> Within allotted time</li> <li>• <span style="background-color: yellow; color: black;">Yellow</span> Within scheduled rebuttal time (if applicable)</li> <li>• <span style="background-color: red; color: black;">Red</span> Time expired</li> </ul>
<b>ELECTRONIC DEVICES</b>	Electronic devices must be turned off upon entering a courtroom but counsel may use electronic devices, including laptops, in silent mode while seated at the counsel tables.
<b>IDENTITY OF THE PANEL</b>	The identity of the judges sitting on the panel hearing this case will not be disclosed until the morning of argument. Panel members will be posted outside of the courtroom and on the court's website the morning of argument.
<b>ORDER OF CASES</b>	Cases are called in the order listed on the calendar posted outside the courtroom and on the court's website. While waiting, counsel should remain in the courtroom or its immediate vicinity.
